**PLEASE READ THE FOLLOWING INFORMATION:** At the start of every camp day each camper must be signed in on the daily sign in sheet. If the person picking up the child that day is not the legal guardian of the child the name of the person picking up the child must be specified on the daily sign in sheet. Children who are not picked up by 4:15 pm will be placed in childcare at the parent's expense (\$6 per hour fee).

All campers will be given 1 snack and 1 juice box each day of camp. Snacks will contain no nuts. If your child has additional allergies please pack a small snack with your camper each day. We ask that individual snacks are only brought if an allergy makes it absolutely necessary, not simply because of likes and dislikes. We encourage campers to bring a water bottle with their first and last name clearly written on it. And for camp sessions in which campers will be outside playing tennis please send your child with sunscreen on. All camp activities are active and sports related. Please dress your child in shoes with laces and clothing in which they can move. No sandals, crocs or slip on shoes.

Each Friday campers will have the chance to swim from 3 to 4 pm. All parents are welcome during swim time! Only children who are water safe – able to swim 8 feet in open water independently without help - will be able to swim without a parent present. If your child is not water safe you may pick them up at 3 pm or arrive at 3 pm to supervise your child while they swim. Please note that camper pick up on Friday will take place at the pool. Children must be signed out and follow the same procedures as all other camp days. Please specify below what your camper will be doing on Fridays:

## WAIVER OF RELEASE OF LIABILITY
